URGENT ACTION NEEDED, LODGE YOUR OBJECTION TO MBRC LOCAL CANAL LAW BY FRIDAY 31 MARCH 2023

Congratulations on a record attendance of 106 Newport residents at the Scouts Hall on February 21st as well as the largest public attendance of a MBRC open council meeting at the Redcliffe Leagues club on 1st March.

Your submissions to MBRC are still needed before 31st March. Newport residents, husbands, wives and even children over 18 years can lodge one.

The key issues we have with the proposed MBRC Local Laws include.

(1) Transfer of cost and responsibility for revetment walls to landowners

(2) Access to private property (without notice or warrant) breaching privacy.

(3) Formal MBRC Wall Repair Notice issued following neighbours' complaint.

(4) MBRC has power to recover costs for this repair work from your estate.

(5) MBRC require you to provide a disclosure to purchasers of potential cost and risk to your revetment walls.
